On this day the Texas Board of Nursing, hereinafter referred to as the Board considered the matter of ANNA SHAREE WHITE, Registered Nurse License Number 558254, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may have violated TEX. REV. CIV. STAT. ANN. ART. 4525(b)(9), (eff. date 09/01/1997). Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order offered on March 29, 2011, by Katherine A. Thomas, MN, RN, Executive Director.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
2. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
3. Respondent is currently licensed to practice professional nursing in the State of Texas.
4. Respondent received an Associate Degree in Nursing from Houston Community College, Houston, Texas, on August 1, 1989. Respondent was licensed to practice professional nursing in the State of Texas on March 23, 1990.
5. Respondent's nursing employment history is unknown.
6. On or about September 15, 1997, Respondent entered a plea of Nolo Contendere to ASSAULT (a 3rd Degree felony offense committed on November 16, 1996), in the 174th District Court of Harris County, Texas, under Cause No. 738008. As a result of the plea, the

proceedings against Respondent were deferred without entering an adjudication of guilt and Respondent was placed on probation for a period of three (3) years. Additionally, Respondent was ordered to pay a fine and court costs.

On June 4, 1998, a 1st Order Modifying Conditions of Community Supervision was entered in the 174th District Court of Harris County, Texas, ordering Respondent to participate in the Substance Abuse Felony Punishment Facility (SAFPF) for a term of not less than six (6) months or more than one (1) year; and ordering Respondent to participate in the Harris County Community Supervision & Corrections Department's Substance Abuse Felony Punishment Facility Specialized Caseload, beginning upon discharge from SAFPF. In addition, Respondent's supervision was extended seven (7) years, beginning September 14, 2000, with a new expiration date of September 14, 2007. Respondent was discharged from community supervision on September 21, 2007.

7. On or about June 4, 1998, Respondent entered a plea of Nolo Contendere and was convicted of ASSAULT (a Class A misdemeanor offense committed on March 21, 1998, reduced from Felony Assault), in the 174th District Court of Harris County, Texas, under Cause No. 778450. As a result of the conviction, Respondent was sentenced to confinement in the Harris County Jail for a period of one (1) year. Additionally, Respondent was ordered to pay court costs.

#### CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove a violation of TEX. REV. CIV. STAT. ANN. ART. 4525(b)(9), (eff. date 09/01/1997).
4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 558254, heretofore issued to ANNA SHAREE WHITE, including revocation of Respondent's license(s) to practice nursing in the State of Texas.

#### ORDER

IT IS THEREFORE AGREED and ORDERED that RESPONDENT SHALL receive the sanction of REMEDIAL EDUCATION, and RESPONDENT SHALL comply in all respects with

the Nursing Practice Act, Texas Occupations Code §§301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.1 *et seq.* and this Order.

IT IS FURTHER AGREED and ORDERED that, while under the terms of this Order, this Order SHALL apply to any and all future licenses issued to Respondent to practice nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license(s) is/are encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a nurse licensure compact privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED that:

(1) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in Texas nursing jurisprudence and ethics. RESPONDENT SHALL obtain Board approval of the course prior to enrollment only if the course is not being offered by a pre-approved provider. Home study courses and video programs will not be approved. In order for the course to be approved, the target audience shall include nurses. It shall be a minimum of six (6) contact hours in length. The course's content shall include the Nursing Practice Act, standards of practice, documentation of care, principles of nursing ethics, confidentiality, professional boundaries, and the Board's Disciplinary Sanction Policies regarding: Sexual Misconduct; Fraud, Theft and Deception; Nurses with Substance Abuse, Misuse, Substance Dependency, or other Substance Use Disorder;

and Lying and Falsification. Courses focusing on malpractice issues will not be accepted. RESPONDENT SHALL CAUSE the sponsoring institution to submit a Verification of Course Completion form, provided by the Board, to the Office of the Board to verify RESPONDENT's successful completion of the course. This course shall be taken in addition to any other courses stipulated in this Order, if any, and in addition to any continuing education requirements the Board has for relicensure. *Board-approved courses may be found at the following Board website address:* <http://www.bon.state.tx.us/disciplinaryaction/stipscourses.html>.

IT IS FURTHER AGREED, that upon full compliance with the terms of this Order, all encumbrances will be removed from RESPONDENT'S license(s) to practice nursing in the State of Texas and RESPONDENT shall be eligible for nurse licensure compact privileges, if any.
