ORDER OF THE BOARD

On this day, the Texas Board of Nursing, hereinafter referred to as the Board, accepted the voluntary surrender of Registered Nurse License Number 242564, issued to BONNIE ELAINE TRILICEK, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Respondent is currently licensed to practice professional nursing in the State of Texas.
2. Respondent waived representation by counsel, informal proceedings, notice and hearing.
3. Respondent received a Baccalaureate Degree in Nursing from The University of Texas Health Science Center School of Nursing, Houston, Texas, on December 1, 1977. Respondent was licensed to practice professional nursing in the State of Texas on March 21, 1978.
4. Respondent's nursing employment history includes:

5. At the time of the incident in Finding of Fact Number Seven (7), Respondent was employed as a School Nurse with Lamar County Independent School District, Rosenberg, Texas, and assigned to Navarro Middle School, Rosenberg, Texas, and had been in this position for seven (7) years.
6. On December 30, 2008, the Board provided notice to Respondent for the following allegations:
 - a. On or about November 14, 2008, while employed as a School Nurse with Lamar County Independent School District, Rosenberg, Texas, and assigned to Navarro Middle School, Rosenberg, Texas, Respondent failed to accurately and completely assess Student C.R. when the student presented to the clinic with multiple abrasions and bleeding from an elbow injury. Student C.R. was an eleven (11) year old student who was on aspirin therapy because of a congenital heart condition that required an arterial switch and bypass graft of her right coronary artery when she was six (6) years old. Instead, Respondent cleaned the abrasions with wet paper towels, dried the abrasions with dry paper towels, applied triple antibiotic ointment to the abrasions and applied a cold compress to the elbow, then had the student return to gym class. Subsequently, the student was taken to an acute care emergency room where she was evaluated, a splint was applied to her arm and an appointment was made with an orthopedic physician.

- b. On or about November 14, 2008, while employed as a School Nurse with Lamar County Independent School District, Rosenberg, Texas, and assigned to Navarro Middle School, Rosenberg, Texas, Respondent failed to notify the parent of Student C.R. of the student's injuries. Instead, the parent was informed of the injuries by the student at the end of the school day.
7. On January 7, 2011, the Board received a notarized statement from Respondent voluntarily surrendering the right to practice nursing in Texas. A copy of Respondent's notarized statement, dated January 4, 2011, is attached and incorporated herein by reference as part of this Order.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(10)&(13), Texas Occupations Code, and 22 TEX. ADMIN. CODE §§217.11(1)(A),(1)(B),(1)(M),(1)(P) &(3)(A) and 217.12(1)(A),(1)(B)&(4).
4. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
5. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
6. Any subsequent reinstatement of this license will be controlled by Section 301.452 (b), Texas Occupations Code, and 22 TAC §§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.


ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Registered Nurse License Number 242564, heretofore issued to BONNIE ELAINE TRILICEK, to practice professional nursing in the State of Texas, is accepted by the Executive Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL NOT practice professional nursing, use the title of or the abbreviation RN or wear any insignia identifying herself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order.
3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice professional nursing in the State of Texas.
