On this day, the Texas Board of Nursing, hereinafter referred to as the B accepted the voluntary surrender of Registered Nurse License Number 625616, issued to KAREEM KENNEY, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c) of the Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was provided to Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
2. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
3. Respondent is currently licensed to practice professional nursing in the State of Texas.
4. Respondent received a Baccalaureate Degree in Nursing from Prairie View A&M College, Houston, Texas, on December 1, 1995. Respondent was licensed to practice professional nursing in the State of Texas on February 5, 1996.

6. On December 30, 2009, Respondent was issued an Agreed Order by the Texas Board of Nursing requiring her to participate in the Texas Peer Assistance Program for Nurses (TPAPN). A copy of the December 30, 2009, Agreed Order, Findings of Fact and Conclusions of Law is attached and incorporated, by reference, as part of this Order.
7. On or about November 24, 2009, Respondent was convicted of DRIVING WHILE INTOXICATED (A Class B Misdemeanor offense committed on May 17, 2009) and CRIMINAL MISCHIEF >\$50<\$500 (A Class B Misdemeanor offense committed on October 28, 2009) in The County Criminal Court at Law No. 5 Houston, Houston, Texas, under Cause No. 160049401010. As a result of the conviction, Respondent was ordered to court confinement of sixty (60) days, and ordered to pay court costs.

8. On or about December 21, 2009, Respondent submitted a Texas Board of Nursing- Online Renewal Document, Registered Nurse, in which she provided false, deceptive, and/or misleading information, in that she answered "no" to the following question, in relevant part::

"Have you, within the past 24 months or since your last renewal, for any criminal offense, including those pending appeal:

- a. been convicted of a misdemeanor?
- f. been sentenced to serve jail or prison time? court-ordered confinement"

On or about November 24, 2009, Respondent was convicted of DRIVING WHILE INTOXICATED ( A Class B Misdemeanor offense committed on May 17, 2009) and CRIMINAL MISCHIEF >\$50<\$500 (A Class B Misdemeanor offense committed on October 28, 2009) in The County Criminal Court at Law No. 5 Houston, Houston, Texas, under Cause No. 160049401010. As a result of the conviction, Respondent was ordered to court confinement of sixty (60) days, and ordered to pay court costs. Respondent's conduct was deceiving and may have affected the Board's decision to license her.

9. On or about March 27, 2010, Respondent became non-compliant with the Agreed Order issued to her by the Texas Board of Nursing on December 30, 2009. Non-compliance is the result of her failure to comply with all requirement of the TPAPN contract, in that she failed to enroll in Intensive Outpatient Treatment, stopped calling the drug testing system, missed a drug screen when selected on May 12, 2010, and allowed her drug testing account to be suspended for non-payment. Stipulation Number Three (3) of the Agreed Order Dated December 30, 2009, reads, in pertinent part:

(3) RESPONDENT SHALL comply with all requirements of the TPAPN contract during its term.

10. On or about June 7, 2010, Respondent entered a plea of "Guilty" to AGGRAVATED ASSAULT CAUSING SERIOUS BODILY INJURY(a Second Degree felony offense committed on May 9, 2010) in the 183rd Harris County District, Houston, Texas, under Cause No. 126237201010. As a result of the plea, the proceedings against her were deferred without entering an adjudication of guilt and she was placed on Court Probation for a period of four (4) years. Additionally, Respondent was ordered to pay court costs.
11. On or about July 14, 2010, Respondent verbally stated her desire to voluntarily surrender her license to staff of the Texas Board of Nursing.
12. Respondent, by her signature to this Order, expresses her desire to voluntarily surrender her license(s) to practice nursing in the State of Texas.
13. The Board policy implementing Rule 213.29 in effect on the date of this Agreed Order provides discretion by the Executive Director for consideration of conditional reinstatement after proof of twelve (12) consecutive months of abstinence from alcohol and drugs followed by licensure limitations/stipulations and/or peer assistance program participation.

14. The Board finds that there exists serious risks to public health and safety as a result of impaired nursing care due to intemperate use of controlled substances or chemical dependency.

#### CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(3)&(10), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(9),(11)(B)&(13).
4. The evidence received is sufficient cause pursuant to Section 301.453(a), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 625616, heretofore issued to KAREEM KENNEY, including revocation of Respondent's license(s) to practice nursing in the State of Texas.
5. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
6. Under Section 301.453(d), Texas Occupations Code, as amended, the Board may impose conditions for reinstatement of licensure.
7. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 TEX. ADMIN. CODE §213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

#### ORDER

NOW, THEREFORE, IT IS AGREED and ORDERED that the VOLUNTARY SURRENDER of Registered Nurse License Number 625616, heretofore issued to KAREEM KENNEY, to practice nursing in the State of Texas, is accepted by the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

2. RESPONDENT SHALL NOT practice professional nursing, use the title "registered nurse" or the abbreviation "RN" or wear any insignia identifying herself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
3. RESPONDENT SHALL NOT petition for reinstatement of licensure until:

one (1) year has elapsed from the date of this Order; and, RESPONDENT has obtained objective, verifiable proof of twelve (12) consecutive months of sobriety immediately preceding the petition.

4. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.





On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of KAREEM KENNEY, Registered Nurse License Number 625616, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may have violated Section 301.452(b)(9),(10)&(12), Texas Occupations Code. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order offered on December 3, 2009, by Katherine A. Thomas, MN, RN, Executive Director.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license.
2. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
3. Respondent is currently licensed to practice professional nursing in the State of Texas.
4. Respondent received a Baccalaureate Degree in Nursing from Prairie View A & M College, Houston, Texas on December 1, 1995. Respondent was licensed to practice professional nursing in the State of Texas on February 5, 1996.

6. At the time of the incident described in Finding of Fact Number Seven (7), Respondent was employed as a Registered Nurse with All About Staffing, Houston, Texas, and had been assigned to West Houston Medical Center, Houston, Texas, but at the time of the incident, was on maternity leave.
7. On or about January 1, 2008 through June 16, 2008 while employed as a Registered Nurse with All About Staffing and assigned to West Houston Medical Center, Respondent obtained Vicodin under her own name, through the use of a fraudulent oral or telephonically communicated prescription, using the name and Drug Enforcement Agency (DEA) number assigned to Elvis Torres, M.D. Respondent's conduct was likely to deceive the pharmacy and possession of Vicodin through use of a forged, unauthorized, fraudulent telephonically communicated prescription is prohibited by Chapter 481 of the Texas Health and Safety Code (Controlled Substances Act).

8. At the time of the incident in Finding of Fact Number Nine (9), Respondent was employed as a Registered Nurse with All About Staffing, Houston, Texas, and assigned to Thomas Street Health Center, Houston, Texas and had been in this position for six (6) months.
9. On or about December 1, 2008 through December 22, 2008 while employed as a Registered Nurse with All About Staffing, Houston, Texas, and assigned to Thomas Street Health Center, Houston, Texas, Respondent lacked fitness to practice professional nursing, in that her breath smelled of alcohol, she was observed sniffing a wad of alcohol wipes and one of her assigned patients reported that Respondent told her that she was too drunk to drive and had her mother drive her to work. Respondent's conduct could have affected her ability to recognize subtle signs, symptoms or changes in patients' conditions, and could have affected his/her ability to make rational, accurate, and appropriate assessments, judgments, and decisions regarding patient care, thereby placing the patients in potential danger.
10. At the time of the incident in Finding of Fact Number Eleven (11), Respondent was employed as a Registered Nurse with Harris County Hospital District-LBJ Hospital, Houston, Texas, and had been in this position for ten (10) months.
11. On or about August 1, 2009, while employed as a Registered Nurse with Harris County Hospital District-LBJ Hospital, Houston, Texas, Respondent removed Vicodin from the medication dispensing system for patient MR#070161435 and attempted to substitute Ibuprofen to administer to Patient MR#070161435 instead. Additionally, Respondent failed to to document, or accurately document the administration of the medication in the patients' Medication Administration Record and/or nurse's notes.
12. The Respondent's conduct described in the preceding Findings of Fact was reportable under the provisions of Sections 301.401-301.419, Texas Occupations Code.
13. The Board finds that there exists serious risks to public health and safety as a result of impaired nursing care due to intemperate use of controlled substances or chemical dependency.
14. Respondent denies the use of alcohol described in Findings of Fact Number Nine (9) but admits to taking prescription medication.
15. Respondent's conduct described in Findings of Fact Number Seven (7), Number Nine (9) and Number Eleven (11) resulted from Respondent's impairment by dependency on chemicals.
16. Respondent's compliance with the terms of a Board approved peer assistance program should be sufficient to protect patients and the public.

### CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.455, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violation of Section 301.452(b)(9),(10)&(12), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(10)(A) & (E) & (11)(B).
4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 625616, heretofore issued to KAREEM KENNEY, including revocation of Respondent's license to practice professional nursing in the State of Texas.
5. The Board may, in its discretion, order a nurse to participate in a peer assistance program approved by the Board if the nurse would otherwise have been eligible for referral to peer assistance pursuant to Section 301.410, Texas Occupations Code.

### ORDER

IT IS THEREFORE AGREED and ORDERED that RESPONDENT, in lieu of the sanction of Revocation under Section 301.453, Texas Occupations Code, SHALL comply with the following conditions for such a time as is required for RESPONDENT to successfully complete the Texas Peer Assistance Program for Nurses (TPAPN):

RESPONDENT SHALL deliver the wallet-sized license issued to KAREEM KENNEY, to the office of the Texas Board of Nursing within ten (10) days from the date of ratification of this Order.

(1) RESPONDENT SHALL, within forty-five (45) days following the date of entry of this final Order, apply to TPAPN and SHALL, within ninety (90) days following the date of entry of this final Order, sign and execute the TPAPN participation agreement, which SHALL include payment of a non-refundable participation fee in the amount of five hundred dollars (\$500) payable to TPAPN.

(2) Upon acceptance into the TPAPN, RESPONDENT SHALL waive confidentiality

and provide a copy of the executed TPAPN participation agreement to the Texas Board of Nursing.

(3) RESPONDENT SHALL comply with all requirements of the TPAPN participation agreement during its term and SHALL keep his/her license to practice nursing in the State of Texas current.

(4) RESPONDENT SHALL CAUSE the TPAPN to notify the Texas Board of Nursing of any violation of the TPAPN participation agreement.

IT IS FURTHER AGREED and ORDERED, RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Texas Occupations Code, Section §§301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.1 *et seq.* and this Order.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate licensure privileges, if any, to practice nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license is encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the Texas Board of Nursing and the Board of Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED, SHOULD RESPONDENT fail to comply with this Order or the terms of the participation agreement with the TPAPN, such noncompliance will result in further disciplinary action including revocation of Respondent's license and multistate licensure privileges, if any, to practice nursing in the State of Texas.


