5. On or about September 8, 2009, Respondent submitted a License Renewal Form to the Texas Board of Nursing in which he answered "Yes" to the question: "In the past 5 years, have you been addicted or treated for the use of alcohol or any other drug?"
6. In response to Finding of Fact Number Five (5), Respondent states that he became addicted to prescription Vicodin after being on the drug for three years. He volunteered to enter a treatment center to get off the drug. He was admitted to Audie Murphy Veteran's Hospital on May 13, 2009, for detox for five days. He was then admitted to a 28 day inpatient program, Substance Abuse Residential Rehabilitation Treatment Program (SARRTP). The dates of the program ran from May 29, 2009, to June 17, 2009. He further states that he misunderstood the directions concerning after care and attending group meetings. He thought after care was an option for those that needed more support than the 28-day program offered. His sobriety date is May 14, 2009. Every day he reads a portion of Narcotics Anonymous and Alcoholics Anonymous. This is his plan for relapse prevention. He also reads material he obtained while he was in the 28-day program. He remains under the care of a psychiatrist.
7. On or about November 28, 2009, while employed at Laurel Ridge Treatment Center, San Antonio, Texas, Respondent lacked fitness to practice professional nursing, in that he appeared confused, disoriented, he had slurred speech, a stumbling gait and was found asleep in the dayroom while on duty. Respondent's condition could have affected his ability to recognize subtle signs, symptoms or changes in patients' conditions, and could have affected his ability to make rational, accurate, and appropriate assessments, judgments, and decisions regarding patient care, thereby placing the patients in potential danger.
8. In response to Finding of Fact Number Seven (7), Respondent states that he did fall asleep while serving as night charge nurse on November 28, 2009. He was working the 2nd night of 3 nights of duty on a chemical detox/rehabilitation unit. On or about 0345 hours, he took a 30 minute break from his duties to sit in the dayroom in a soft chair under dim lights. The nurses' station is part of an extension of the dayroom. Therefore, he was within sight and hearing at all times for the LVN and nursing assistant who were maintaining patient care while he took his break. He fell asleep. The next thing he remembered was the nursing supervisor waking him up. He exhibited fairly predictable behavior after one is suddenly awakened in a strange environment. He was momentarily disoriented, confused and when he jumped up, he was unstable on his feet. No drugs or alcohol was involved. This incident occurred over a 20 minute period. In 39 years of professional nursing, this is the first time he ever fell asleep on duty. He was having

some personal/family problems at home and could not obtain more than 3 hours of sleep during the day of the night incident. He was extremely upset at himself and embarrassed. He knew that sleeping on duty was a cause for immediate dismissal.

9. On April 12, 2010, Respondent submitted a notarized statement to the Board voluntarily surrendering the right to practice professional nursing in Texas. A copy of the statement dated April 12, 2010, is attached and incorporated, by reference, as part of this Order.
10. The Board policy implementing Rule 213.29 in effect on the date of this Agreed Order provides discretion by the Executive Director for consideration of conditional reinstatement after proof of twelve (12) consecutive months of abstinence from alcohol and drugs followed by licensure limitations/stipulations and/or peer assistance program participation.
11. The Board finds that there exists serious risks to public health and safety as a result of impaired nursing care due to intemperate use of controlled substances or chemical dependency.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(9)(10)&(12), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(1)(E)&(5).
4. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
5. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
6. Any subsequent reinstatement of this license will be controlled by Section 301.452 (b), Texas Occupations Code, and 22 TAC §§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Registered Nurse License Number 550288, heretofore issued to DEAN ROY DAAKE, to practice professional nursing in the State of Texas, is accepted by the Executive Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL NOT practice professional nursing, use the title of registered nurse or the abbreviation RN or wear any insignia identifying himself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order; and, RESPONDENT has obtained objective, verifiable proof of twelve (12) consecutive months of sobriety immediately preceding the petition.
4. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate licensure privilege, if any, to practice professional nursing in compact states.
