AGREED BOARD ORDER

On this day came to be considered by the Board of Vocational Nurse Examiners for the State of Texas, hereinafter referred to as the Board, the matter of vocational nurse license number 078404, previously held by CAROLYN JEAN RAIBON, aka CAROLYN HENSON, hereinafter called Applicant.

Applicant has submitted a written request for reinstatement of said previously held license. By Order dated May 3, 1989, the Board of Vocational Nurse Examiners found that Applicant had violated the Vocational Nurse Act, or a rule, regulation or Order issued under the Vocational Nurse Act, Texas Revised Civil Statutes Annotated, Article 4528c.

A prehearing conference was held on January 6, 1992, at the office of the Board of Vocational Nurse Examiners. The conference was conducted by Marjorie A. Bronk, R.N., Executive Director of the Board, assisted by Norma Jean Clark, L.V.N., member of the Board of Vocational Nurse Examiners. Applicant was present and was not represented by counsel.

The conference was attended by Cynthia Kinton, Investigator for the Board, and Chris Maczka, Assistant Attorney General. By her notarized signature on this Order, Applicant does hereby waive the right to Notice of Formal Hearing and a Formal Hearing on the Application for Reinstatement before the Board, and to judicial review of this disciplinary action after this Order is endorsed by the Board.

After reviewing the matters relative to the Application for Reinstatement at the prehearing conference, Applicant agrees to the entry of an Order dispensing with the need for further action on this application. By Applicant's signature on this Order, Applicant acknowledges that she has read and understood this Order and has approved it for consideration by the Board. ORDER OF THE BOARD

THEREFORE, PREMISES CONSIDERED, the Board of Vocational Nurse Examiners does hereby order that license number 078404, previously issued to CAROLYN JEAN RAIBON, aka CAROLYN HENSON be reinstated, suspended, with said suspension stayed and placed on probation for a period of one (1) year.

The probation of said license is subject to the following stipulations to wit:

1. That Applicant shall cause her nursing employer(s) to submit satisfactory reports to the Board office on a quarterly basis throughout the term of probation.
2. That Applicant shall not be employed by a nurse registry/temporary nurse agency or as a private duty nurse throughout the term of probation.
3. That Applicant shall work only under the direct supervision of a licensed medical professional throughout the term of probation.
4. That Applicant shall not work in an autonomous nursing position throughout the term of probation.
5. That Applicant shall attend A.A. or N.A. and shall cause her program sponsor/counselor to submit satisfactory quarterly reports to the Board office throughout the term of probation.
6. That Applicant shall submit to random periodic urine drug screens upon demand of the Board staff. Said screens shall be properly monitored with adherence to chain of custody procedure. The results of said screens shall be submitted to the Board office by the laboratory. The expense of said screens shall be borne by Applicant.

That Applicant must enroll in or audit and successfully complete a nursing program course encompassing the following areas of study: Pharmacology Review and submit documentation of successful course completion to the Board office within six (6) months of said probation. Said course shall be in-house at a community college, university, or nursing program or tutored by a state-approved, licensed nursing program faculty member. The expense of said course shall be borne by Applicant.

8. That any period(s) of unemployment must be documented in writing by Applicant and submitted directly to the Board office on a quarterly basis throughout the term of probation.

9. That if Applicant's place of employment, name, address or telephone number changes, Applicant is to notify the Board office immediately.

It is also ordered that shall comply with all the provisions of Article 4528c, Revised Civil Statutes of Texas.





Dear Ms. Raibon:

This office is in receipt of information alleging that while employed as a Licensed Vocational Nurse at Community Hospital in Tyler, Texas you were responsible for discrepancies in the documentation and administration of narcotics, and you allegedly diverted Demerol for your own use. It is further alleged that you acknowledged your chemical dependency and sought treatment, but that you failed to continue with rehabilitation efforts.

You are afforded this opportunity to respond to the allegations that have been made and to show that you have complied with all requirements of the Vocational Nurse Act for the retention of your license to practice vocational nursing in Texas.

In the event the allegations are true you may be interested in a provision of the Vocational Nurse Act (V.A.C.S., 4528c) for the Voluntary Surrender of a license. The return of the license along with your notarized statement that you no longer wish to practice vocational nursing will enable the Board to revoke your license without formal charges, Notice or a hearing. We are enclosing such an affidavit form for your consideration.






